The Golf Club

The Croydon Golf Club was established in 1925 and over the years has earned the reputation of being the premier golf club in the eastern suburbs. Now located on 330 acres in the Yarra Valley, the World Class course designed by Architect Ross Watson is arguably the finest in the area. Croydon is renowned as a very friendly club and the clubhouse facilities provide the ideal surroundings for the relaxation and enjoyment of members and guests.

Golf Course

The eighteen hole, 6400m layout consists of fairways covered with pure Legend Couch and the Greens are Bent Grass. The course is in excellent condition and is a challenge of golfers of all abilities.

Golf Competitions

The Club conducts golf competitions for Men on a Wednesday, Thursday, Saturday & Sunday; for Women on Tuesday, Thursday and Sunday; and for Men and Women on Public Holidays

Clubhouse & Facilities

The Members Lounge and Terrace Café are open each day for all to enjoy the relaxing environment; all televisions throughout the building have Foxtel and TVN for your entertainment.

The Grove Restaurant is open for a la carté dining on Wednesday through to Saturday evenings from 5:30pm onwards and Sunday lunch from 12.30pm to 3.30pm.

We also cater for functions and conferencing from as small as 6 people in The Hamilton White Room to as big as 120 people in The Vista Room.

Golf Shop

Our Club Professionals Geoff George and Michael Waghorn have an extensive range of golfing equipment and services including tuition, club cleaning & storage, and hire equipment. The Golf Shop co-ordinates the entry process and starts the field for all club competitions.

Practice

They say “practice makes perfect” and to fine tune your game we have a number of practice facilities. There are practice fairways*, a putting green, a chipping green, a pitching green, and driving nets; all available to playing members any day, any time.

*Practice Range is managed by the Golf Shop, golf balls can be purchased at a price of \$4 for a bucket of 40 golf balls.

Corporate Membership

Whether for business or pleasure Corporate Membership will be rewarding for your company and for you. 7-Day Members

Are entitled to use the Course seven days a week and to enter all major events. Currently 7 Day Membership is not available however we are accepting applications for the 7 Day Waiting List. Conditions do apply to be placed on the waiting list .

6-Day Members

Are entitled to all the rights and privileges of Membership, except as follows; 6 Day members are not entitled to use the Course on Saturdays, unless playing in a mixed competition partnered by a Member entitled to play on Saturdays, or in a special competition designated 'open' by the Committee.

Intermediate Members

Are persons aged 18 to 23 years who, on joining, are entitled to the same rights and privileges as 6 Day Members. Seven day playing rights are available on request.

Junior / Cadet Members

Are persons aged 8 to 17 years who are entitled to the same rights and privileges as 6-Day Members. 7 day playing rights are available on request.

Social Members

Social Members are entitled to utilise the Clubhouse facilities only.

Membership Application

Applications for Membership should be made by correctly completing the attached form and returning it to the Club. For playing members the Club will promptly confirm receipt of your application and invite you to attend the next scheduled playing membership induction meeting. Playing Membership inductions take place once a month on a Wednesday Evening at 7pm. Play is only available upon payment and from the day after the membership induction meeting.

The Clubs' corporate membership and financial year is from July to June. New corporate members joining throughout the financial year are charged on a pro-rata basis.
