RULES FOR NOMINATION OF CANDIDATES FOR MEMBERSHIP

The **PROPOSER** requests the Membership Nomination forms Part A, B, C, D and E from the General Manager and any queries regarding these are to be discussed with the General Manager.

- 1 It is the Proposer's responsibility to make application to the Club for the Membership Nomination forms for Candidate, Proposer, Secunder and three Referees. The Proposer should forward the forms to the Secunder and three Referees and they are to complete and return these to the Proposer, who forwards to the General Manager with Candidates non-refundable deposit (10% of current Entrance Fee).
- 2 The Proposer must be absolutely satisfied that the Candidate is a person suitable for membership of the Club and meets the standards befitting a member of the Club. The Proposer must have regard primarily to his/her obligations to the Club rather than to the Candidate and the Proposer shall remain responsible for the conduct for the duration of the Candidates Membership. All Candidates will be interviewed - prior to the offer of Membership.
- 3 a A Proposer, a Secunder and three Referees are required and must all be current Members of the Club. The Proposer and Secunder must be playing Members of the Club for a minimum of 2 years and the three Referees must be members of not less than 2 years.
b A Proposer, Secunder and Referees must have known the Candidate for a minimum of 2 years
c Only one member of the same family can act as a Proposer, Secunder or Referee for a non-family member.
- 4 When a Member proposes immediate family (wife, husband, daughter, son, father, mother, grandchildren) the Secunder must be a non-family member.
- 5 A member may not propose or second more than two Candidates in any one Club Year (July-June) without specific approval of the Committee
- 6 The Candidate should have an adequate standard of golfing knowledge and of the rules and etiquette of the game. **It is expected that the Proposer shall have played golf with the Candidate prior to submission of the application.**
- 7 The Candidate must apply for Membership in the Category preferred - ie. Full (7-day) or Intermediate (6-day). The Candidate will initially be placed on the Waiting List and vacancies depend on Approved Quotas.
- 8 Once the Candidate has been elected to membership, the Proposer is to play golf with and introduce the Candidate to other members and generally familiarise the Candidate with the Club rules and etiquette and request the Secunder and Referees to assist with this. For this reason it is preferred that male and female Candidates be nominated and supported by their own sex.
- 9 Nomination Forms must be completed and returned to the General Manager within 3 months of the issue date.
