PROCEDURE FOR THE PROPOSAL OF NEW MEMBERS

This form must be completed in all aspects prior to proposal for membership of the Club being considered.

A proposer must be at least the same category of membership as that of the person to be proposed for membership. For example, a Weekday Member cannot propose an applicant for Provisional or Full Membership.

Please consider proposing a new member carefully, particularly as you will take on important responsibilities both to the Club and to the applicant.

Responsibilities of the Proposer (to the Club and the Applicant):

1. The Proposer and Seconder must be current financial members and have held membership of the Club for at least twelve (12) months.
2. Must have known the applicant personally for a minimum of two years thus ensuring their suitability for membership. Business and social aspects are important to ensure that the applicant will fit easily into the golf and social environments of the Club.
3. Must have knowledge of the various categories of membership available and the rights and privileges associated with each category. This will assist in ensuring the correct category of membership is applied for. (Where necessary the Office staff will outline the various categories.)
4. Must ensure that the Applicant understands the financial obligations of membership. By lodging an application the Applicant acknowledges the initial financial obligation, together with any future fee increases, without hardship or embarrassment.
5. Must make himself/herself known to the Applicants intended Seconder (*a Member of Southern Golf Club, who has known the Applicant for a minimum period of two years*). The Seconder may be required to provide a written reference.
6. Should the application be approved, the Proposer may be required to attend the Membership Induction Meeting of the nominee. (Should the Proposer be unavailable, the Seconder may be required to attend).
7. Should the applicant be successful, the Proposer is required to make it their personal responsibility to introduce the new Member into the golfing and social activities of the Club. Furthermore, the initial responsibility rests with you for the conduct of the new Member introduced.
8. Applicants will be required to pay the entrance fee applicable at the time of being admitted to the Club. The Membership Committee wish to make clear to the applicant that this entrance fee may be different from the date of application.

In Conclusion: As the Proposer or Seconder, should you have any concerns, if there is any doubt in your mind, or if the Applicant is of short-term acquaintance, your strong consideration should be given to the proposal of this application. In making your decision, the Clubs best interests should be of priority, keeping in mind that the applicant is being introduced to the Club on your recommendation.
